

That a declaration be made that the Defendant is in default of payment of the principal sum payable under the terms of the First Charge registered on 17 June 2010 and shown by Instrument No. 5308/09 made between the Defendant and the Plaintiff, by virtue of which the property in the Registration Section Savannah, Block 27C, Parcel 187 H3 (the "Property") was charged by the Defendant by way of legal charge in favour of the Plaintiff to secure the principal sum of CI\$183,000.00 and interest at the rate of 5.25%.
2. That the Charge be enforced by sale of the Property by private treaty as well as by public auction.

3. That the property be listed for sale on the MLS system.
4. That the Defendant and any other person occupying the Property vacate the Property, within 30 days of this Order, and take all appropriate steps to deliver possession of the Property to the Plaintiff.
5. That the terms and conditions of sale be determined, if any.
6. That leave be granted to issue a Writ of Possession in relation to the Property at the expiry of the 30 days referred to in paragraph 4 above.
7. Such further or other relief as this Honourable Court may deem appropriate.

And let the Defendant within 14 days of service upon him of this summons, including the day of service, return the accompanying acknowledgment of service to the Courts office.
